
In partial modification of this Department Memo No.F.II-3/KST/BLG/2014/(Part)/3431-62 dated 13-05-2014 the Governor has been pleased to make enhancement of the rate of tiffin allowance from Rs.6.00 to 8.00 (Rupees eight) only per head per prisoner attending the Court subject to observance of the following condition until further order.

- i) Only the prisoners who are required to remain in Court beyond 1.P.M. shall be entitled to tiffin.
- ii) The items of tiffin shall be restricted to Banana or Bread or Egg or Tea or more than one of the said items or all the items **within Rs.8.00**.
- iii) The Officer-in-charge of the Police Court shall arrange supply of the tiffin at the Police lockup after 1.P.M. through Court Canteen and certify daily challans of the Canteen indicating number of prisoners served and items served on the basis of which bills shall be paid by the Superintendent, Kendriya Sansodhanar, Tripura, Bishalgarh, District Jail & Sub-Jails.

The expenditure involved on this account shall be borne from Non-Plan Non-Salary under Head of Account 2056-Jails 00-101-99-62-23 against Demand No.36.

This has got concurrence of the Finance Department vide their U.O.No.1056/Fin(G)/14 dated 20-09-2014.

This will take immediate effect.
