MEMORANDUM.

In partial modification of this Department Memo.No.F.II-3/CJ/2009/PART/6947-86 dtd. 30-9-2014, the Governor has been pleased to make enhancement of the cost of tiffin/food from **Rs.8.00 to 30.00/-**(Rupees thirty) only per head per prisoner attending the Trial Court, subject to observance of the following condition :

- i) Only the prisoners who are required to remain in Court beyond 1.P.M shall be entitled to tiffin.
- ii) The items of tiffin shall be restricted to four Roti & Sabji with one cup of Tea or egg & rice or more than one of the said items or all the items, within **Rs. 30.00** per head.
- iii) The Officer-in-charge of the Police Court shall arrange supply of the tiffin at the Police lockup after 1.P.M. through Court Canteen and certify daily challans of the Canteen indicating number of prisoners served and items served on the basis of which bills shall be paid by the Superintendent, Kendriya Sansodhanagar, Tripura Bishalgarh, District Jail & Sub-Jails.

2. The expenditure involved on this account shall be borne from Non-Plan, Non-Salary under Head of Account 2056-Jails 00-101-99-62-23 against Demand No.36.

3.This has got concurrence of the Finance Department vide their U.O.No.1181/FIN(G)/15 dtd.2-11-2015.

This will take immediate effect & until further order.
