If anybody fails to collect the Admit Card before the date of written examination, they will collect the Admit Card from the exam venue at 11 A.M. on 16-10-2022.
4. It is also essential to bring along the previous call letter issued dated 10<sup>th</sup> January, 2022 by Chairman, Reconstituted Recruitment Board earlier, at the examination venue on the day of the written examination.
5. Candidates must bring two copies of pass port size photograph and a photo identity card in original as well as a xerox copy of the same.
6. No TA/ DA will be allowed to the candidates to appear for the said exam.
7. Carrying bags, books, water bottles, food items and mobile phone, tab or any other electronic communication devices etc. inside the exam hall is strictly prohibited.
8. Candidate must submit his Answer sheet to the invigilator before leaving the Examination Hall finally.
